TRAVELWITHKIMMIE assumes no responsibility for and shall not be liable for any refund, personal injury, property damage, or other loss, accident, delay, inconvenience, or irregularity which may be caused by:

- (1) any defaults, wrongful or negligent acts, or omissions of the Suppliers;
- (2) any defect in or failure of any vehicle, craft, equipment, or instrumentality owned, operated, or otherwise used or provided by the Suppliers;
- (3) any wrongful or negligent acts or omissions on the part of any other party not under TRAVELWITHKIMMIE’s control.; and
- (4) any Supplier price drop after your travel arrangements have been confirmed, paid in full, or ticketed.
